The Cloud Based System is an Enterprise Resource Planning (ERP) which incorporates a Property and Facilities Management Module that covers the Financial Management and Lease Management aspects of the property management function. This system has enabled us to effectively manage our properties and produce useful, periodic reports that include Income and Expenditure Reports, Billings and Collections Reports, Tenancy Schedules, Occupancy Reports, Collections Reports, Arrears Position Reports, Tenant Ageing Reports, etc. This has revolutionized our procedures in terms of more efficient management of buildings and easier communication with stake holders. With this new system in place and a new E-Mail communication system, we have remarkably improved our record keeping system and have managed to furnish our clients with up-to-date statements of accounts and reports within a minimal period of time.



ORGANIZATIONAL CHART


